## Service Newsletter January 2023

The Noongar Season 'Birak' (December-January) is represented by the colour red as it symbolises heat, sun and fire. During, Birak season the rain eases and the warm weather really starts to take hold. The afternoons are cooled by the sea breezes from the south west.

Traditionally this was the fire season. An almost clockwork style of easterly winds in the morning and sea breezes in the afternoon meant that this was burning time of the year for Noongar people and they would burn the country in mosaic patterns. There, are several reasons for this, including fuel reduction, increasing the grazing pastures for animals, to aid seed germination and to make it easier to move across the country.

#### Summer is here! What you need to know about pram covers

Covering a pram with a wrap, blanket or plastic cover is not the way to keep the sun off a little one in the pram! Did you know that covering the pram can significantly increase the risk of overheating and suffocation? ## **Checking Hot Surfaces**

With the warmer weather upon us, we would like to remind you all to be aware when children are playing outside or going to play areas where they can be at risk of getting burnt on hot surfaces.

Where possible use play areas where shade sales are installed, and if possible have them installed in your backyard if the area gets particularly hot and there is no other form of shade.

Before children enter the play space, it is recommended to check the temperature of the playground surface. Holding your hand just above the surface may help you determine if the playground surface is too hot for children to play on. If the surface temperature is 50 or more or has been determined to be too hot, it is recommended that children do not play on the surface.

## Medical Incident, Illness, Injury & Trauma

In the event that your child requires any first aid treatment while they are in care, it is essential that your Educator provides you with an *Incident, Injury, Trauma & Illness Record* within 24 hours of the injury / incident occurring. This document must be signed by you and the Educator. If your Educator does not provide you with one of these please ask for one to be completed as this is a Regulatory requirement and while the Service does ask for notification of any serious incidents and medical emergencies, we are not always informed of any other incidents.

## **Disability Discrimination Act**

Every child has the right to access, participate and be included in all aspects of community life, including children's education and care. During visits with our Educators we have been chatting to them about the Disability Discrimination Act and have given them a hand out on what Education and Care Services need to know when working with children and their families.
