Thrive by Five Campaign

We have registered as an official Friend of the Thrive by Five campaign. Thrive by Five is a national campaign, pushing to make early learning in Australia high quality, universally accessible and affordable. Every child should start school ready to learn, with the opportunity to fulfil their potential. This is not currently the case, and evidence shows children who enter the school system developmentally vulnerable often do not catch up with their peers. A high quality, universally accessible and affordable early learning system should be Australia's next great social reform. As an official Friend of the campaign, we have pledged our support for this goal. By joining the campaign, we are showing politicians and the community that we're part of a big movement asking for change. We'll be sharing updates and information about Thrive by Five with you every now and then. Kindy Children No Longer Considered School Age

Please note that the Education and Childcare Regulatory Unit has advised all Family Day Care Services that children who attend Kindergarten at a school are no longer considered school age as of 1st January 2022. This means that your Educator will need to count Kindy children as one of their under 4s. This is a devastating blow to families who have children in Kindy due to the limited availability of spots in this age group. Family Day Care Educators have been advocating to include Kindy children in the school age ratio, but it doesn't appear to be enough. If this is something that impacts on your family have a chat to your Educator to get ideas on how you, as a parent, can be an advocate for this cause.
